A. PARTICIPATION CONDITIONS

1. Organiser

3. Eligibility

participation is prohibited or restricted by local laws or regulations. The Organiser

reserves the right to exclude participants from certain countries if required by applicable

legal or regulatory provisions.

Employees of the Organiser or sales representatives of the Organiser in the countries

where the product giveaway takes place and their relatives are excluded from

4. Participation, time period and place

5. Procedure

To participate, you must register on the Giveaway Webpage before 23:59 pm CET on 31.08.2025 ("Entry Period"). Participation in the giveaway is not dependent on the purchase of a product.

How does the registration work?

6. Winner determination procedure

In the event of a win, we will notify you via your email address provided in the registration by 09.09.2025. You must respond within seven [7] days and provide your mailing address. If you do not reply within seven [7] days, a new winner will be selected, and your prize will be forfeited, and you will have no right to claim the prize or any other compensation.

8. Data protection

Within the scope of the implementation of the giveaway, personal data will be processed in accordance with the following data privacy statements (cf. under B.).

9. Acceptance of the participation conditions

10. Liability

The Organiser is liable for intent and gross negligence. In case of slight negligence, the Organiser shall only be liable in the event of a breach of an essential contractual obligation ("Kardinalpflicht") whose fulfilment is a prerequisite for the proper execution

of the contract and whose observance the participant may regularly rely on, as well as in the event of damage resulting from injury to life, body or health.

11. Premature cancellation or interruption

The Organiser reserves the right to interrupt or prematurely cancel the giveaway if there is a good reason to do so. In particular, compelling legal reasons, such as official orders, changes in the law or other reasons for refusing to hold the giveaway shall be deemed to constitute good reasons for such a course of action in this regard.

12. Applicable law, severability clause

Any disputes arising out of or in connection with the giveaway described above shall be governed by the law of the Federal Republic of Germany, to the exclusion of both the conflict of laws and the United Nations Convention on Contracts for the International Sale of Goods (CISG). The exclusive place of jurisdiction for all legal disputes arising from or in connection with these participation conditions is Hanover. Should one of the clauses of this agreement be or become invalid, the rest of the agreement shall remain unaffected.

B. DATA PRIVACY STATEMENTS

The following personal data may be processed by the Organiser when conducting the giveaway:

This processing is carried out on the basis of the execution and fulfilment of the contractual objectives that follow from the giveaway [article 6 section 1 lit. b) of the GDPR].

The personal data will not be used for purposes other than those described here or passed on to third parties. In particular, the data collected will not be used for other marketing purposes unless an entrant opts-in to receive marketing emails.

- Right to restrict processing The right to restrict a data processing operation.
- Right to data portability The right to transfer personal data directly from one system to another (in machine-readable form).
